


Jeffrey P. Kerekes



INITIATED PROJECTS

Here is a list of some of my more important initiatives.

KEC Newsletter - One was sent out last fall, and another one (the third) is almost ready to be sent out this spring. This was a project I initiated and took responsibility for creating. The second newsletter never made it out due to reasons beyond my control.

Volunteer Policy - In an effort to run a successful volunteer program, I determined that we needed to have a policy in place. I also reviewed and revamped the old volunteer registration and information forms. As a part of this effort I have made contact with the United Way's Volunteer Action Center which operates as a clearing house for people who want to find places to volunteer. I have also set up a volunteer training and orientation day on May 16th and have begun advertising for it.

Intern Program - I initiated our intern program. As a part of this project I wrote up job descriptions, contacted area colleges and faxed/mailed out the descriptions. I have a detailed listing of the internship contacts at the area colleges and have been using that to recruit summer and fall interns. This spring we have had three interns. Two additional interns were here for the month of January. Overall, this has been a successful use of time.

Youth Group Contact Listing - When I came on in May, I was asked to provide programs for area youth groups and I put together a comprehensive listing of these groups. These 75 contacts are now part of our available mailing list.

Press Contact List - Also when I came on board, I needed a new press contact list and sought out to revise and add new places such as tv and radio to the old one. I used this list to advertise the programs I was offering and for recruiting volunteers. This press list was greatly expanded and added to after Lisa Monachelli (intern) addressed it more directly in January, but the initial efforts were important because the old list was outdated and incomplete.

Local Boy and Girl Scout Councils - I made contacts with representatives of these councils in order to increase the number of scout programs we offer. The Girl Scouts advertised our programs to over 9,000 adults, who serve more than 30,000 girls. We have been scheduling scout programs and will be offering a scout program brochure soon that is similar in content and design to the school program brochure.

Educational Field Trip Brochure - This is a result of my efforts in creating the programs and also writing much of the text within the brochure. One intern helped draft this information into the initial version with a lot of input from me. The final draft was also cleaned up with help from Diane and Caryn. This brochure will be instrumental in reaching schools and advertising the Center.

Faculty Meetings - I began visiting schools during their scheduled faculty meetings in order to brief them on the changes here at the KEC as well as to promote our teacher workshops and school program offerings.

Outreach- I initiated contact with Alternative to Incarceration Programs and we have been offering programs to groups such as Youth Continuum (New Haven) and STAR Program (Bridgeport, New Haven and Hartford) throughout the entire year. This has been a rewarding experience and I would like to continue offering programs to these and other groups.

ACCOMPLISHMENTS

For more detailed information on my accomplishments, please refer to the Activity Reports I initiated in June of last year. I have all of the reports on file if you are missing any of these monthly reports.

- In 1996 the KEC had 51 youth and school programs throughout the year. In 1997, from June (when I began) through the end of October (when we stopped scheduling and recruiting schools because we didn't know if I would be here to teach them), we had 48 school and youth programs (over five months).
- Training: Community CPR and First Aid; Project WET Facilitator
- Merit Badge Councilor - I initiated the process to become a certified merit badge councilor for the Boy Scouts. I can offer Bird Study, Nature Study and Environmental Science Merit Badges here at the Center.
- I designed and researched material for the Hebron and Big E Fair exhibit on open space.
- I was the contact person on site during the phone and fax installation and acted as the liaison to the installer. I also programmed the fax machine and had the staff trained on its use.
- I designed our school program policy.
- I created an after school program for Bungay Elementary School.

FUTURE PLANS

Continuing Education - There are several Towns/Regions offering continuing education programs for adults. Trumbull services several thousand each year. We could be offering an extension onto one or more of these existing programs and offer courses in a variety of topic areas. I have laid the foundation for this to happen with three such programs. It would take course development and more contact with these organizations to implement a program.

Field Trips - I would like to offer a series of field trips to the different state parks and forest of Connecticut for adults and high school students. These would be thematic programs that focus on specific topics. This is a great opportunity to offer in conjunction with other organizations such as CFPA, Friends of CT State Parks and Audubon Societies.

Environmental Club - Many high schools offer environmental clubs that vary in the amount they do. I thought it would be great to tap into these groups of interested people and offer a regional environmental club for high school students. The club would explore environmental issues of concern within the State as well as explore topics in ecology and natural history from a balanced perspective.

Inquiry Based Programing - I believe it would be a positive move to make our programs more inquiry based. This would help teachers and students meet their needs for CAP and Mastery testing and provide a more defined context to the programs we currently offer.

Volunteer Program - I would like to spend time developing a solid volunteer program that begins a life of its own, where it sustains itself through word of mouth and internal volunteer leadership. Bill Arnold, a person who expressed becoming our volunteer Volunteer Coordinator (and who is extremely qualified for the position) has some reservations about coming aboard and stated that he would not become the Volunteer Coordinator unless I was going to be here on staff because we have an established professional relationship. If that were to take place, I believe Bill would help expand and solidify our program.

Intern Program - I would like to see the intern program become stronger and to formalize an internship arrangement with area colleges such as SCSU. This has been initiated by Roger and I believe it to be a right step. This would provide a steady flow of interns into the Center in a more formalized arrangement that would be beneficial to all involved.

After school Programs - I would like to offer more after school programs for area elementary schools, such as the Bungay After School Program.


Dear Jeffrey,





Educational Programs For School Field Trips...

Winter Wildlife

Title: "Where the Wild Things are in Winter"

Time: 2 hours

Cost: \$60

When: Mid-November - February

Key concepts: adaptation, hypothermia, habitat requirements, tracking, invertebrate life stages, strategies for survival
Have you ever wondered where the wildlife disappears to in the cold months of winter? Nature's friendly creatures will lead the way as we follow animal tracks to their winter habitats. Searching for living creatures in the brisk of winter will heighten student's awareness of adaptation as well as teaching the essentials for sustaining life.

Forest Community Study

Title: "We All Rely on Each Other"

Time: 2 hours

Cost: \$60

When: March - June, September - November

Key concepts: community, diversity, ecosystem, interrelationship, habitat requirements
Plants and animals that live within a forest community are dependent on one another for survival. Students will learn what keeps a forest alive and the importance of diversity in a community.



Insect Ecology

Title: "Crunch Squish or Squish Crunch?"

Time: 3 hours

Cost: \$90

When: April - June, September - November

Key concepts: insect parts, adaptation, invertebrate, vertebrate, exo and endoskeleton, complete and incomplete metamorphosis

Students will search through a forest, explore a pond and wander fields with nets to capture invertebrates for an in-depth investigation.

The Natural History of Birds

Title: "Birds of a Feather"

Time: 2 hours

Cost: \$60

When: September - June

Key concepts: *bird identification, adaptation, and bird habitats*
Join us for a tour of the world of birds. Students will become bird watchers as they learn where and how to look for our feathered friends, and how to identify species with the use of binoculars and field guides.

Recycling

Title: "What If Nature Didn't Recycle?"

Time: 2 hours

Cost: \$60

When: March - June, September - November

Key concepts: *decomposition, decomposers, nutrient cycling, interdependence, invertebrate, vertebrate, the five Rs, composting*
"Rethink, Reduce, Reuse, Repair and Recycle" are the five Rs needed to be practiced by all. Students will discover nature's decomposers and investigate the organisms responsible for decomposition. They will bring a simple vermicomposting system back to the classroom.

Nature Stations

Title: "Station Rotation"

Time: 2 hours

Cost: \$60

When: September - June

Key concepts: *major insect parts, seed dispersal, aquatic vs. terrestrial turtles, tree identification, bird differences*
An introduction by name is a great way to remember new friends, the names stick even better when you have to do some work to learn them. This rainy day activity will enable students to identify insects, turtles and birds by rotating through "nature stations."



Pond Ecology

Title: "Livin' Where It's Wet"

Time: 3 hours

Cost: \$90

When: April - June, September - November

Key concepts: *invertebrates, diversity, pollution, catch and release, life stages of insects*
The Pond Ecology program investigates the aquatic life of a pond -- from the aquatic dragonfly nymph to the aerial adult; from the tiny tadpole to the giant bull frog. Pond Ecology includes field collection, exploration, and a classroom component where microscopes and identification complete the lesson.



Registration...


Registration for these programs is required. Enrollment is limited to 25 students per program, however, more than one classroom may enroll for a given day with the availability of additional KEC staff. All programs must be accompanied by a minimum of one adult for every ten students, with a preference for one for every five. For further information or program registration, phone (203) 734-2515, or fax (203) 922-7833. The Center is located at 500 Hawthorne Avenue, Derby, CT.

Participant Guidelines...

- All programs are conducted rain or shine. We offer indoor programs when necessary. For severe weather cancellations, we encourage you to reschedule.
- Programs are suitable for students grades 4 and up.
- Special programs require 4 weeks notice and are only available if preparation time is sufficient.
- Adequate clothing for outdoor classes is essential for students, teachers and chaperones. Come prepared with rain gear, waterproof footwear, hats, gloves and warm clothing during cold weather. Programs may involve a couple of hours in the field.
- The group has the most fun when everyone participates, including teachers and chaperones. Come prepared to join in!
- Pre-lesson activities will be sent to you upon registration. Students learn more when they have an opportunity to cover key concepts prior to the field trip.
- Picnic lunches are permissible, with a carry-in, carry-out policy for all trash. We encourage recycling at the center. Your students can recycle most juice containers, soda cans and even food scraps at our center.
- Please call us if you will be late on the day of the field trip. If a group arrives late, the program will be shortened by that amount of time.

HOW TO FIND US

From Eastern Connecticut (I-95 Southbound)

- after crossing Quinnipiac Bridge, take exit 47 (=Rte. 34 connector)
-stay on connector until it ends
- proceed straight to junction with Ella Grasso Boulevard
- take a right onto the Boulevard and move quickly to the left lane
- at the first intersection, take a left onto Rte. 34
- continue west on Rte. 34
- in Derby, Rte. 34 makes a hard left turn over the Naugatuck River and passes under Rte. 8
- see Getting Close directions below

From Southwestern Connecticut (I-95 Northbound)

- from I-95, take exit 27 to Rte. 8
- from Rte. 8, take exit 15
- at end of ramp, turn left onto Rte. 34
- see Getting Close directions below

From the North on Rte. 8 (Southbound)

- take exit 15
- at end of ramp, turn left onto Main St. (Rte. 34)
- see Getting Close directions below

From the South on Rte. 8 (Northbound)

- take exit 15
- at end of ramp, turn left onto Main St. (Rte. 34)
- see Getting Close directions below

From the Wilbur Cross (Northbound)

- take exit 52 onto Rte. 8 North
- from Rte. 8, take exit 15
- at end of ramp, turn left onto Main St. (Rte. 34)
- see Getting Close directions below

From the Wilbur Cross (Southbound)

- take exit 58 (2nd exit after West Rock Tunnel) and go right on Rte. 34
- in Derby, Rte. 34 makes a hard left turn over the Naugatuck River and passes under Rte. 8 overpass
- see Getting Close directions below

Getting Close

In Derby: from Main Street Rte. 34/Rte. 8 intersection (overpass)

- continue West on Rte. 34 for about 1.5 miles
- take a right onto Lakeview Terrace (there is a sign for Kellogg/Osbomedale just before the road) and continue to stop sign
- turn left at stop sign
- our parking lot is on your left. Welcome!
